 - Sweeps Committee– Michael Peterson-Sweeps data entered through February, March entry in progress. Jonmarc Truesdale and Clyde Green are in the process of auditing July through January results.
 - Guidebook Committee-Michael Peterson- All chapters are converted into Word from the 2021 edition. Recommend updating "History of the Blues" and "Development of the Chocolate Silver Fox" and of course the C&BLs section. Are there any other sections that require updating?
 - Scholarship Committee-Bill Brockman-After waiting for possible late entries for the scholarship applications. I am proud to say we will have our first ever scholarship award for Convention this year. We only received 1 application, Kaitlin Konnick form Florida. Kaitlin has been very active in Silver Fox for several years and has been actively involved in mentoring youth in her home state. Kaitlin is also on the Board of Directors for the Southeast Silver Fox Rabbit Breeders. Kaitlin is currently attending Florida State College in Jacksonville, Florida, working towards a degree in Animal Nutrition and Biotechnology.
 - Marketing Committee- Lisa Summey-Many thanks to our members who supported the club through purchasing merchandise created for the 2024 National Show in Decatur, IL. The marketing committee has been working towards offering a variety of items to our members. Our product offerings for the national show were well received by the members and the total units sold exceeded the previous year. Our goal is quality items while keeping prices reasonable for members. We feel that we achieved that while making a profit of almost four hundred dollars for NSFRC.

One goal that our national club discussed this last year was to work towards having our awards for big shows be in line with our merchandise offerings in that they would share a common theme or design. We made an excellent start towards that goal with this past national show. We used the marketing committee's design on several of the awards. Both the marketing and awards committees were well pleased with the results and we hope that our members were too.



 Awards Committee-Heather Kaiser-The awards committee has been working with the sweeps committee to get the plaques and remaining medallions for the 22-23 sweeps sent out. The awards have been ordered and made, as well

as sent out. We are sorry for the delay and thank the club members for their patience and understanding.

For the 2024 national show there were 77 awards excluding any 1-6 placement ribbons. The total spent for awards was \$1120.36. The BOB, BOSB and the best of group variety awards were made by Still Waters Designs. Ribbons for best of the best and 1st place ribbons for classes were ordered through Stineman Ribbon Company. Blankets for the best display were created and ordered through VistaPrint. The grooming bags and decals were ordered through Amazon and Ninja transfers. The BOV & BOSV were obtained by Nancy with embroidery donated by JW Everts. With the marketing committees help we were able to make a coherent theme with both the awards and merchandise offered at the show. Both committees will continue working together moving forward.

- Election Committee- We are about to become very active in the next months with the election of the following positions: President, Secretary, and 3 Board Members.

Discussion of who on the Election Committee might be running for election for the next term. Hollie Kremer said she was thinking of not running due to family commitments, Karen Waldrop said she might run but was still looking to see how crazy her work schedule may be next year. Suzel Bozada-Deas and Roxanna Dabney both stated that they would be able to serve on the committee with no problem. (Latter addition: Hollie Kremer will not be

running for re-election but would like to continue to serve on the Election Committee.

The 2024 Election

The committee was informed by Roxanna that NSFRC is not ready for an online election this year. Then the committee discussed how to run the election better. First it was discussed how to take the mystery out of the election by explaining the process; especially, how to put together a petition. (This discussion was prompted by some of the responses on follow-up survey given at Convention 2023.) We also discussed petitions to run for office. It was agreed that a list of questions might help potential candidates. Here are some suggestions the election committee would like to see addressed in the petitions:

All persons running for office

- Any information membership needs to know about you (and possibly your family)
- Your skills and qualifications
- Contact information
- Your vision of Silver Fox and stewardship of the breed for the future
- What projects you have worked on to support the club? Or other similar experience that might be an asset to NSFRC

• What project(s) you hope to work on during a potential term? Items we think would be good for those who have previously served on the board:

- What were your major contributions and duties to NSFRC while in office?
- How do you feel about those contributions?
- What contributions do you see yourself making in another term?

Future Online Election Discussions

The committee discussed potential issues that need to be addressed to facilitate online voting. There was discussion about whether online voting should be done by household or each voting member should be able to vote separately. The committee noticed that household are not voting the same. This was also true for the poll regarding Foxcon. Generally, households did vote similarly for the SOP changes. It was decided to see how ARBA handles online voting.

Actions since the Election Committee last met

Newsletter articles have been written and submitted to Victoria Lanter. Supplies and postage (postage is going up again) have been ordered by

Roxanna for the next election so that Suzel Bozada-Deas has more assistance assembling the voting packets. The committee is continually reviewing the by-laws to make sure we are in better compliance.
