- Awards Committee Report: Heather Sheaffer Passing out a survey of what the membership wants to see for awards. Working with Marketing to be cohesive on designs. Looking forward to FoxCon awards.
- o Marketing Committee Report: Lisa Summey We just had a wonderful marketing campaign for convention. As we have switched chairs, our goal is to make sure we are offering quality products to our members at an affordable price. We feel we have succeeded in doing that. The second goal is to over more variety than what was previously offered, including color options and merchandise. This too, we feel was a goal met. The third goal was to work closely with awards committee for a more cohesive design for National and Convention shows. So, what's next? Plan is to have future merchandise with NSFRC logo and for specific shows available on the website. We have one design for FoxCon and would like to come up with another. - National Bid Committee Report: Hannah Ramirez The show committee reviewed the 2 bids submitted for 2026 Nationals (GA, WA). The committee unanimously recommended a PNW nationals for 2026 in WA. The NSFRC BOD voted to conditionally approve the location of 2026 nationals based on the location of 2026 Convention. If 2026 goes to NV, then 2026 Nationals will go to GA. If 2026 goes to SC, then 2026 Nationals will go to WA. We were informed that 2026 Convention will go to Reno, NV, so 2026 Nationals will be

held in Dalton, GA on March 6-8 weekend, 2026. We were also informed that 2027 Convention will be held in Greenville, SC, and the BOD is discussing approving 2027 Nationals for WA. We are still accepting bids for 2027 Nationals through July 2025.

- Sweeps Committee Report: Vernon Brown is replacing Mike Peterson as chair. Sweeps is a huge undertaking. Teamwork and delegating is going to be very important. Looking to delegate to multiple people on the committee. Talking points from Mike Peterson - Final sweeps numbers have been reported & are on the website. In the last year, the social media team has done a phenomenal job with our outreach efforts. And before we get to the statistics, I want to give a massive shout-out to Kara Perez, Lisa Summey, Kacy Knapp, Callie DeHaven, and Kelly Cosenza; for all of your hard work to make our page great! Within in the last year, our facebook page has had an organic reach of over 25,000, which is an increase of 38.1%. The number of times people visited our page was down by 6.9% for a total of 14,100 visits. Lastly, we had 342 new followers which is 10.9% lower than last year. With the help from the membership sharing our posts, we can reach more of an audience and encourage more breeders to join our club.
